

SUNRISE RECORDS' FANSTASTIC BEASTS: THE CRIMES OF GRINDELWALD PREMIERE CONTEST OFFICIAL RULES AND REGULATIONS

SUNRISE RECORDS' FANSTASTIC BEASTS: THE CRIMES OF GRINDELWALD PREMIERE CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN CANADA, INCLUDING QUEBEC, AND SHALL ONLY BE CONSTRUED AND EVALUATED ACCORDING TO CANADIAN LAW. THE CONTEST IS OPEN TO LEGAL RESIDENTS OF CANADA ONLY. NO PURCHASE IS NECESSARY. THIS CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES ("CONTEST RULES").

1. ELIGIBILITY. To be eligible for this Contest, an individual must:

- be a legal resident of Canada
- be of the age of majority in his/her province of residence or older at time of entry and have internet access. Employees, officers and agents of 2428391 Ontario Inc. ("Sunrise Records" or "Sponsor"), Warner Bros. Entertainment Canada, Inc. (the "Prize Provider"), each of their respective affiliates, subsidiaries, advertising and promotional agencies, and the household members or immediate family of any of the above, are not eligible to participate in the Contest. In these Contest Rules, "immediate family" means husband, wife, spouse, mother, father, brothers, sisters, sons and daughters, whether or not they reside in the same household. By entering this Contest, you agree to completely release Warner Bros. Entertainment Canada, Inc. and its parent, affiliates and subsidiaries from any liability.

2. DEADLINES FOR ENTRY. The Contest begins at 9:00 am Eastern Time ("E.T.") on Thursday, August 23rd, 2018 and closes on Friday, November 16th, 2018 at 11:59 pm E.T (the "Contest Period"). Deadline for Grand Prize entry is Tuesday, October 23rd, 2018 at 11:59pm ET.

3. HOW TO ENTER. To be eligible to win a Prize (defined below) as indicated, each Entrant may enter once online at <https://sunriserecords.com/fantastic-beasts-contest/> and complete the entry process as requested. Entrant must also accept to be bound by the Contest Rules to officially enter the Contest. All entries ("Entries") must be submitted no later than the end of the Contest Period. All Entries become the property of the Sponsor. Entries will only be accepted via Internet. No Entries will be accepted by any other means. Incomplete, late or garbled Entries will be disqualified. Entries will be declared made by the authorized holder of the email account. Each potential winner ("Winner") may be requested to provide Sponsor with proof of identification and eligibility (birth date) and proof that the potential Winner is the authorized holder of the email account associated with the winning entry.

The only method of entry for this Contest is an online entry (internet access required). Online entry is available through the Website only; no other means of submission will be accepted. Although online access is required in order to participate, no purchase is required in order to enter the Contest. Many public libraries, retail businesses and others offer free access to computers.

4. PRIZES. (referred to herein as "Prizes"). There is one (1) Grand Prize available to be won, consisting of:

- (i) One (1) pair of Run-of-engagement (ROE) passes to see *Fantastic Beasts: The Crimes of Grindelwald* in theatres, valid Monday-Thursday at participating Cineplex locations commencing 10 days after the Picture opens until its run in individual participating Cineplex theatres concludes.

Approximate retail value of each secondary prize is \$25.00 CAD.

For the Grand Prize: Address of premiere screening theatre will be provided by the Sponsor a reasonable time prior to the premiere. The winner and his/her travelling companion (the "Travelling Companion") are advised to arrive at least one (1) hour prior to premiere screening start time. **No one will be admitted without a ticket or after the premiere screening begins.** If, for whatever reason, the premiere screening of the Picture is cancelled or rescheduled after the tickets are ticketed, no compensation will be paid in lieu of any cancelled or rescheduled showing of the Picture. No responsibility is assumed by the Sponsor if the premiere

screening is cancelled, rescheduled, delayed or postponed, in whole or in part. Unused tickets cannot be refunded or exchanged. Screening tickets do no gain entrance to after party.

5. WINNER SELECTION. There will be two (2) Winner Selection dates, as set forth below:

- (ii) On Monday, November 19th at approximately 9:00 a.m. ET at the offices of the Sponsor in Ancaster, ON, twenty (20) random draws for the secondary prizes will take place from all eligible Entries received during the Contest Period.

Each selected entrant must meet all of the eligibility criteria set out in these Contest Rules. If the selected entrant does not meet the eligibility criteria, he/she will be disqualified and will not receive a prize and another entrant will be selected.

The chances of being selected to win the Grand Prize in this Contest depend on the total number of eligible entries received up to the Grand Prize entry deadline.

The chances of being selected to win a secondary prize in this Contest depend on the total number of eligible entries received during the Contest Period.
